**TYPE OF ENTRY:**  **Vendor Booths 12'D X 15'L-Food booths 12'Dx20'L – This includes, towing tongue, tent, etc.** Please do not exceed the space limit or you will be asked to LEAVE. Signs must be within festival guidelines and not to interfere with power lines. Vendors may be asked to remove signs if this occurs. There is a limited (6) number of spaces that can accommodate generators. Please note if you would like to have one of the generator spaces. Generator must be quiet

(NO Sales, No Raffle, Etc.) *501C3 or Government Agency*
- Non-Profit Vendor (Church or civic Organization)** **\$75.00**  
(Sale of Food, Craft or Raffle) *501C3 or Government Agency*
- Commercial Products, Crafts, Businesses for Profit** **\$100.00**  
(\*See Below for what we MUST HAVE for your booth to be approved)
- Food Vendor –** **\$150.00**  
Vendor is responsible for additional Permit with Health Department – [www.harnett.org](http://www.harnett.org)
- Political Booths (Workers must remain in Booth, will not** **\$125.00**  
Be allowed to walk around to hand out Political Literature.  
Limited to 5 booths per Party: Rep. – Dem. – Non-Partisan)
- Electricity (110 V outlet 20 amp limit) 1 receptacle with 2 plugs** **\$25.00**  
per space. (see example to the right) If you need more than 2  
“plugs” please order accordingly! There are a limited number of  
vendor spaces with access to electricity.



**FOOD VENDORS:**  
You **MUST** list **ALL** foods you will be **SELLING** the day of the festival. If you bring foods to sell **not listed** you will not be allowed to sell them. We **DO NOT** duplicate items so we **HAVE** to know **EVERY ITEM**. If you do not send a list, your application **WILL BE SENT BACK!**  
**Any one cooking MUST have a Fire Extinguisher.**

**\*\*\*ALL VENDORS: WHAT WE NEED FOR YOUR APPLICATION TO BE APPROVED: A photo of your booth layout is required. You MUST list all items you will be selling either attached or on the back of the application. If you DO NOT supply a list of items your application WILL be sent BACK. NO EXCEPTIONS!!! If you are selling items the day of the festival that you did not list, you WILL be asked to LEAVE. NO REFUND!**

**\*\*Vendors are to remain in their booth at ALL times to sell their product. You will not be allowed to walk around handing out promotional items, this includes Political Candidates! Applications will not be processed without payment.**
