TYPE OF ENTRY: Vendor Booths 12'D X 15'L - Food Trucks/Trailers 15'Dx30'L – This includes, towing tongue, tent, etc. Please do not exceed the space limit or you will be asked to LEAVE. Signs must be within festival guidelines and are not to interfere with power lines. Vendors may be asked to remove signs if this occurs. Generator must be quiet.

Non-Profit Info/Display Only *Must be a "not for profit" organization* **\$55.00**
(NO Sales, No Raffle, Etc.) 501C3 or Government Agency- *Vendors are ONLY permitted to hand out information pertaining to the organization. No promotion of social agendas will be permitted. Violators of this policy will be excused from the festival and will not be permitted into future events.*

Non-Profit Vendor (Church or civic Organization) **\$80.00**
(Sale of Food or Raffle) 501C3 or Government Agency- *Vendors are ONLY permitted to hand out information pertaining to the church or civic organization. No promotion of social agendas will be permitted. Violators of this policy will be excused from the festival and will not be permitted into future events.*

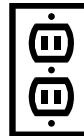
Local Artisan (Handmade Crafts & Products) **\$55.00**

Commercial Products, Businesses for Profit **\$110.00**
(**See Below for what we MUST HAVE for your booth to be approved)

Food Trucks/Trailers **\$150.00**
Food vendors are responsible for additional Permit with Harnett County Health Department -www.harnett.org, as well as responsible for obtaining City of Dunn Food Truck Permit -www.cityofdunn.org
Trailers are not permitted to be attached to vehicles for the festival.

Political Booths (Workers must remain in Booth) **\$130.00**
Limit 1 booth per Party: Rep. – Dem. – Non-Partisan.
Will NOT be allowed to walk around to hand out Political Literature.

Electricity (110 V outlet 20-amp limit) 1 receptacles with 2 plugs **\$30.00**
per space. (see example to the right) If you need more than 2 "Plug ins" please order accordingly! There are a limited number of vendor spaces with access to electricity.



FOOD VENDORS:
You MUST list ALL foods you will be SELLING the day of the festival. If you bring foods to sell not listed you will not be allowed to sell them. If you do not send a list, your application WILL BE SENT BACK! We have 4 food districts and are trying to avoid duplications within each district. Anyone cooking MUST have a Fire Extinguisher. Fire Marshall will be inspecting The morning of the event. You will not be allowed to open your booth until properly equipped!

*****ALL VENDORS: WHAT WE NEED FOR YOUR APPLICATION TO BE APPROVED:**

- You MUST list all items you will be selling either attached or on the back of the application. **PLEASE PROVIDE LIST OF ITEMS YOU WILL BE SELLING.** If you are selling items the day of the festival that you did not list, you WILL be asked to LEAVE. **NO REFUND!**
- **Vendors are to remain in their booth at ALL times to sell their product.**
- **Vendors are prohibited from packing up and leaving early. Violators will not be permitted into future events.**
- **Applications will not be processed without payment.**
